RESOLUTION NO. 60-2023

WHEREAS, it is the declared policy of the state to provide the people with adequate and decent housing facilities and to encourage various stakeholders to participate in the housing program of the government;

WHEREAS, pursuant to the Local Government Code (R.A 7160) and the Urban Development and Housing Act of 1992 (RA. 7279, Local Government Units (LGU's) are mandated to take principal role in the provision of housing services to its constituents;

WHEREAS, the National Housing Authority(NHA), pursuant to the declaration of the Supreme Court in the case of Mandanas vs. Executive Secretary (G.R. Nos. 199802 and 208488), as further mandated by Executive Order No. 138, series of 2021, implemented full devolution of housing functions to the LGUs, especially, those classified as 1st to 4th class LGUs;

WHEREAS, in a letter by the Department of Budget and Management (DBM) to the NHA, dated 07 June 2022, the former declared that the NHA is not precluded from proposing budgetary requirements to 1st and 4th class LGUs, so long as the NHA has determined the lack of capacity of the said LGUs to implement the housing functions;

WHEREAS, the Budget Office of this LGU issued a Certification that the funds of this LGU cannot support housing projects which can have significant impact on the poverty level under this LGU's jurisdiction;

NOW, THEREFORE, on motion by Hon. Jocelyn M. Chua, duly seconded, it was

RESOLVED, to support, as this August Body hereby supports that LGU cannot, on its own, implement the housing function devolve to it under the Mandanas vs. Executive Secretary ruling, this August Body passes this resolution and requests that NHA to allocate funds for the LGU's constituents in relation to housing projects;

RESOLVED, FINALLY, that a copy of this Resolution be furnished to Engr. Al-Khwarizmi U. Indanan, Regional Manager, thru Engr. Mary Jane D. Antipuesto, OIC, NHA, Pagadian City for their information and favorable action;
