MUNICIPAL ORDINANCE 04 - 2009

REGULATING THE OPERATION OF VIDEO 5 AND AUDIO-VISUAL APPARATUSES OR SOUND SYSTEMS IN THE MUNICIPLAITY OF BUUG AND IMPOSING PENALTIES FOR ANY VIOLATION THEREOF

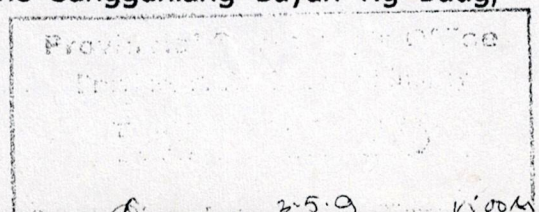
WHEREAS, gradually, Buug has attained a certain degree of socio-economic development; this can be seen in the sprouting of business establishment that cater to the needs and wants of the town residents;

WHEREAS, among the business establishment that operate in the municipality are video 5 and audio-visual apparatuses or sound system which operate and usually receive customers only during night time;

WHEREAS, it is sad to note, that video 5 and audio-visual apparatuses or sound system usually break the stillness of the night as noise pollution resulting from the unregulated sounds of video 5 machines or the voices of video singers seems to be reigning the video 5 establishments; the occupants of the houses located near or around the video 5 establishments can hardly sleep during the period from 9:00 p.m. to 12:00 midnight by reason of the fact that customers/singers usually sing to the top of their voices, especially when they are at the influence of liquor; they remain doing said activity even up to 2:00 am the following day;

WHEREAS, inasmuch as video 5 and similar establishments operate up to the night time, there is a need to regulate the operation of the same, especially the night time operation;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan Ng Buug, Zamboanga Sibugay;



SECTION 1. Regulated Acts. No person shall operate such business establishment without first securing a permit from the Office of the Municipal Mayor and paying the corresponding fees imposed under existing municipal tax ordinances.

SECTION 2. Rules and Regulations. Such business establishments shall operate in accordance with the following rules and regulations:

1. No video 5 and audio-visual apparatuses or sound system shall be constructed, established or permitted to operate within a radius of one hundred (100) lineal meters from any educational, religious or public institutions such as schools, hospitals, clinics, churches, and government offices. Further, this provision shall not apply to existing video 5 establishments.
2. Operation of video 5 during night time shall be up to, and only up to 12: 00 midnight.
3. Operators or managers shall immediately report to the PNP or to the authority concerned all those customers who, despite repeated request or appeals on them to leave the subject place, still refuse to leave at the time stated above.
4. Other necessary rules and regulations that are not inconsistent herewith may be issued by the Municipal Mayor for the proper implementation of this ordinance.


SECTION 3. Penalty. Any violations of the provisions of this ordinance shall be punished by law:

- a. 1ST offense - warning
- b. 2nd offense - 500.00
- c. 3rd offense - 1,000.00 and cancellation of business license


SECTION 4. Repealing Clause. All Municipal Ordinance, Resolutions, circulars, rules and regulations inconsistent with any of the provision of this ordinance are hereby repealed or modified accordingly.

SECTION 5. Effectivity Clause. This Ordinance shall take effect upon its approval by the Sangguniang Bayan of Buug, Zamboanga Sibugay.
