**MUNICIPAL ORDINANCE NO. 07-2009**

AN ORDINANCE AMENDING SECTION 48 OF ARTICLE 14 OF MUNICIPAL ORDINANCE NO. 01-2005, KNOWN AS THE ECOLOGICAL SOLID WASTE MANAGEMENT ORDINANCE

WHEREAS, the Board had decided to amend Section 48, Article 14 of Municipal Ordinance No. 01-2005 otherwise known as the Ecological Solid Waste Management Ordinance of Buug to make the collection of fees more workable based on some in depth studies, learning and observation from places visited by the ESWM TWG;

NOW, THEREFORE, BE IT ORDAINED, as it is HEREBY ORDAINED by the Sangguniang Bayan of the municipality of Buug, Zamboanga Sibugay, that:

SECTION I. Amending Section 48 of Article 14 of the Municipal Ordinance No. 01-2005 known as the Ecological Solid Waste Management Ordinance of Buug;

SECTION 48. Fees for Households – Garbage collected from households shall be charged of P2.00 per kilo for residuals and P1.00 per kilo for special waste.

SECTION 2. Effectivity. This Ordinance shall take effect upon its approval.

ENACTED AND APPROVED this 16<sup>th</sup> day of February 2009 during the 7<sup>th</sup> regular session of the Sangguniang Bayan of Buug, Zamboanga Sibugay.
