MUNICIPAL REGULATORY ORDINANCE NO. 08-2009

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan Ng Buug:

Section 1. Title – "AN ORDINANCE IMPLEMENTING CHAPTER XXVI-DISPOSAL OF DEAD PERSONS AS PROVIDED FOR IN PRESIDENTIAL DECREE NO. 856 KWON AS CODE SANITATION OF THE PHILIPPINES."

Section 2. Burial Grounds Requirements - The following requirements shall be applied and enforced:

- a. It shall be unlawful for any person to bury remains in the places other than those legally authorized in conformity with the provisions of the Code Sanitation of the Philippines.
- b. No remains shall be buried in the residential lot of this municipality;
- c. A cemetery/memorial park shall be a distance of at least 50 meters from the side of the river and or 50 meters from the source of water supply;

Section 3. Penal Provisions:


- a. Any person who shall violate, disobey, omit or neglect to comply with any of the rules and regulations promulgated under this ordinance shall be guilty of misdemeanor and upon conviction shall be punished by imprisonment for a period not exceeding six months (6) or by a fine of not exceeding one thousand pesos (P1,000.00) or both depending upon the discretion of the court.

- b. Any person who shall interfere with or hinder, or oppose any officer, agent or member of the Department and Offices under it, in the performance of his duty as such under this Ordinance, shall be guilty of misdemeanor and punishable upon conviction by imprisonment for a period not exceeding 6 months or by a fine or not exceeding 1,000.00 pesos or both depending upon the discretion of the court.


Section 4. Effectivity. This shall take effect upon its approval.


