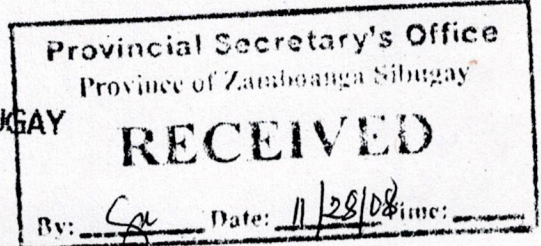

MUNICIPAL ORDINANCE NO. 05 – 2008

AN ORDINANCE ADOPTING AND ESTABLISHING THE BOUNDARY LINES OF THE MUNICIPAL WATERS OF THE MUNICIPALITY OF BUUG, ZAMBOANGA SIBUGAY AS DETERMINED AND IDENTIFIED BY THE NATIONAL MAPPING AND RESOURCES INFORMATION AUTHORITY (NAMRIA) AND IN ACCORDANCE TO R.A. 8550 OTHERWISE KNOWN AS THE PHILIPPINE FISHERIES CODE OF 1998

WHEREAS, Republic Act No. 8550, also known as the Philippines Fisheries Code of 1998, provides for the development management and conservation of the Fisheries and Aquatic Resources and integrates all laws pertinent thereto;

WHEREAS, Section 16, of R.A. No.8550 provides that the Municipal Government shall have jurisdiction over Municipal Waters as defined therein;

WHEREAS, pursuant to and subject to the exclusion clause of Section 458 of R.A. 8550, otherwise known as the Philippine Fisheries Code of 1998, the municipal water of the municipality of Buug, Province of Zamboanga Sibugay are bounded by the general coastline of the municipality and the lines described as follows:

BE IT ORDAINED BY THE HONORABLE SANGGUNIANG BAYAN OF BUUG, ZAMBOANGA SIBUGAYA PROVINCE IN SESSION ASSEMBLED THAT:


SECTION 1. TITLE. This Ordinance shall be known and thereafter referred to as **"AN ORDINANCE ADOPTING AND ESTABLISHING THE BOUNDARY LINES OF THE MUNICIPAL WATERS OF THE MUNICIPALITY OF BUUG, ZAMBOANGA SIBUGAY AS DETERMINED AND IDENTIFIED BY THE NATIONAL MAPPING AND RESOURCES INFORMATION AUTHORITY (NAMRIA) AND IN ACCORDANCE TO R.A. 8550 OTHERWISE KNOWN AS THE PHILIPPINE FISHERIES CODE OF 1998"**.

SECTION 2. Repealing Clause All ordinances, resolutions or laws of local application and effect inconsistent hereto modified, superseded and repealed accordingly;


SECTION 3. Separability Clause. If, for any reason or reasons, any part or provisions hereto shall be held to be unconstitutional or invalid, other parts or provisions hereto which are not affected thereby shall continue to be in full force and effect;

Section 4. Effectivity. This ordinance shall take effect immediately upon approval;


