MUNICIPAL ORDINANCE NO. _____ 2006

WHEREAS, the late MELCHORA C. GONZALES had been a Municipal Vice Mayor of this municipality year 1968-1971 and during her incumbency, had contributed much to the progress of the community and the upliftments of the living condition of the inhabitants;

WHEREAS, it is but incumbent and humane that for her valuable deeds, she should be given a distinguished honor in her memory;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan Ng Buug, Zamboanga Sibugay;

SECTION 1. Title. - This Ordinance shall be known and cited as "AN ORDINANCE RENAMING THE B. GONZALES STREET TO MELCHORA GONZALES STREETS STARTING FROM CANOY ENTERPRISES ESTABLISHMENT ALONG THE NATIONAL HIGH WAY GOING TO PANAS STREET".


SECTION 2. Policy. - It is the established policy of this local government to give distinguish honor to any individual who, in her life, dedicated much to the service to the people and progress of the community;



SECTION 4. Effectivity - This Ordinance shall take effect immediately upon its approval.


