MUNICIPAL ORDINANCE NO. 14-2025

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 07-2024, ENTITLED "AN ORDINANCE HONORING AND GRANTING CASH INCENTIVES TO OCTOGENARIANS, NONAGERIANS, AND CENTENARIANS, IN THIS MUNICIPALITY" BY CHANGING AND INCREASING THE CASH INCENTIVES GRANTED UNDER SECTION 3:B OF SAID ORDINANCE.

BE IT ENACTED BY THE SANGGUNIANG BAYAN OF BUUG, ZAMBOANGA SIBUGAY, THAT:

SECTION 1. AMENDMENT OF SECTION 3:B OF MUNICIPAL ORDINANCE NO. 07-2024. The amendment is made to Section 3:B of Municipal Ordinance No. 07-2024, which currently reads as follows:

2.1. Original Provision of Section 3:B:

- a. **Octogenarians (80-89 years old):** ₱500.00
- b. **Nonagenarians (90-99 years old):** ₱1,000.00
- c. **Centenarians (100 years old and above):** ₱10,000.00

2.2. Amended Provision of Section 3:B:

- a. **Octogenarians (80-89 years old):** ₱1,000.00
(increase from ₱500.00)
- b. **Nonagenarians (90-99 years old):** ₱2,000.00
(increase from ₱1,000.00)
- c. **Centenarians (100 years old and above)**
₱10,000.00 (no change)

SECTION 2. JUSTIFICATION FOR THE CHANGES:

- 2.1. **Octogenarians:** The cash incentive for **Octogenarians (80-89 years old)** has been increased from **₱500.00** to **₱1,000.00** to provide more meaningful recognition for individuals who reach this milestone.
- 2.2. **Nonagenarians:** The cash incentive for **Nonagenarians (90-99 years old)** has been increased from **₱1,000.00** to **₱2,000.00** in recognition of their exceptional longevity and contribution to the community.
- 2.3. **Centenarians:** The cash incentive for **Centenarians (100 years old and above)** remains **₱10,000.00** as no change is necessary in this category based on the overall funding considerations.

This amendment aims to adjust the cash incentives to reflect an enhanced recognition for the elderly, particularly Octogenarians and Nonagenarians, while maintaining the previous incentive for Centenarians.


SECTION 3. REPEALING CLAUSE. The provisions of previous local enactments, resolutions, memoranda, circulars, and other issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 4. SEPARABILITY CLAUSE. Should any portion of this Ordinance be declared ultra vires or unconstitutional by competent authority, the remainder not so affected shall continue to be in full force and effect as it is susceptible to enforcement and application.

SECTION 5. EFFECTIVITY. This ordinance shall take effect immediately upon its approval;
