**MUNICIPAL ORDINANCE NO. 48-2024**

**AN ORDINANCE IMPOSING FEES AND ESTABLISHING A SHARING SCHEME FOR THE USE OF THE ONE UNIT FOUR-WHEEL DRIVE TRACTOR.**

**WHEREAS**, the Municipality of Buug recognizes the need to efficiently manage and equitably share the use of the Four-wheel Drive Tractor to support agricultural productivity and sustainability;

**WHEREAS**, the Municipality of Buug has acquired the Four-Wheel Drive Tractor from the Department of Agriculture - Philippine Center for Postharvest Development and Mechanism (DA-PHilMech) to benefit the local farming community;

**NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF BUUG:**

**SECTION 1. TITTLE.** This Ordinance shall be known as "AN ORDINANCE IMPOSING FEES AND ESTABLISHING A SHARING SCHEME FOR THE USE OF THE ONE-UNIT FOUR WHEEL DRIVE TRACTOR"

**SECTION 2. PURPOSE.** The purpose of this ordinance is to establish a fee structure and a sharing scheme for the use of the Four-wheel Drive Tractor to ensure fair access, cost recovery, and efficient operation;

**SECTION 3. DEFINITIONS**

1. **Tractor:** Refers to the Four-wheel Drive Tractor TYM 5825R as described in the acquisition documents.
2. **User:** An individual or entity that reserves and uses the Four-wheel Drive Tractor.
3. **Reservation Period:** The timeframe during which the Four-wheel Drive Tractor is reserved by a User.
4. **Fee:** The amount charged for the use of the Four-wheel Drive Tractor as specified in this ordinance.
5. **Dicer:** Shall contact costumer on the usage of the Four-wheel Drive Tractor.

**SECTION 3. FEE STRUCTURE**

1. **Basic Usage Fee:** The fee for using the Four-wheel Drive Tractor shall be **₱3,500** per hectare, subject to adjustment based on operational costs.
2. **Operational Cost:** The total operational cost shall be charged against Basic Usage Fee per hectare.

**SECTION 4. RESERVATION USAGE AND REPORTING**

1. **Reservation Process:** Users must reserve the Four-wheel Drive Tractor at least one month in advance before the scheduled harvest.
2. **Cancellations:** Users must provide at least one week notice for cancellations of their reservations.

**SECTION 5. REVENUE DISTRIBUTION**

1. **Fee Collection:** Fees shall be collected by the Municipal Treasurers Office and deposited into the Trust Fund.

## **SECTION 6. ENFORCEMENT**

1. **Compliance:** Users must adhere to all terms specified in this ordinance. Violations may result in penalties, including suspension of access privileges.
2. **Audits:** Periodic audits shall be conducted to ensure compliance with the fee structure and reservation policies.

**SECTION 7. AMENDMENTS.** This ordinance may be amended as necessary by the Sangguniang Bayan to address changes in operational needs or community feedback.

**SECTION 8. REPEALING CLAUSE** - The provisions of previous local enactments, resolutions, memoranda, circulars, and other issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.

**SECTION 9. SEPARABILITY CLAUSE** - Should any portion of this Ordinance be declared ultra vires or unconstitutional by competent authority, the remainder not so affected shall continue to be in full force and effect as it is susceptible to enforcement and application.

**SECTION 10. EFFECTIVITY.** This ordinance shall take effect immediately upon its approval and compliance with the posting and publication requirements set forth in Republic Act No. 7160;
