Invitation to Bid for the DEVELOPMENT OF MUNICIPAL PARK PHASE 1

1. The Local Government Unit of Buug, Zamboanga Sibugay, through the 20% DEVELOPMENT Fund of 2026 intends to apply the sum of FIVE MILLION NINETY NINE THOUSAND FIVE HUNDRED NINETY FIVE PESOS & 17/100 ONLY (Php5,099,595.17) being the Approved Budget for the Contract (ABC) to payment under the contract for the DEVELOPMENT OF MUNICIPAL PARK PHASE 1. Bids received in excess on the ABC shall be automatically rejected on the bid opening.

2. The Local Government Unit of Buug now invites bids for the above project. Bidders should have completed within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

3. Bidding will be conducted through an open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 12009 (RA 12009), otherwise known as the "New Government Procurement Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the BAC Office, 2ND FLOOR, Municipal Hall, Buug, Zamboanga Sibugay and inspect the Bidding Documents at the address given below from 9:00 a.m. to 4:00 p.m.

5. The Local Government Unit will hold a Pre-bid Conference on September 9, 2026 @ 10:00 at the MPDC Office, Ground Floor Municipal Hall, Buug, Zamboanga Sibugay

5. A complete set of Bidding Documents may be purchased by interested bidders from September 2, 2026 starting at 10:00 a.m. to September 21, 2026 at 10:00 Am from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of TEN THOUSAND PESOS (Php 10,000.00).

6. Bids must be delivered to the address below on or before September 21, 2026 at 10:00 a.m. at the MPDO, Municipal Hall, Buug, Zamboanga Sibugay. All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause.

Bids will be opened September 21, 2026 at 10:00 a.m. in the presence of the bidder/bidders' representatives who choose to attend at the MPDC Office, Buug, Zamboanga Sibugay. Late bids shall not be accepted.

8. The Local Government Unit of Buug reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
